Established in 2008 The Mosaic Rooms is a leading contemporary arts space based in London dedicated to supporting and promoting contemporary culture from the Arab world and beyond.

Our vision: To engage our audiences through an informed, engaged and critical understanding of the culture and societies of the Arab world and beyond.

Our values: We aim to be responsive, empathetic, and discursive about the lived cultures of our local and global audience, artists and participants. We offer a curatorial approach that focuses on enabling, supporting, and developing artists and their projects. The Mosaic Rooms plays a vital role in the UK arts ecology, acting as a platform for audiences, participants, cultural programmers, curators, and researchers to engage and learn with.

To advocate for and build effective, sustainable and just practices in cultural institutions, the arts sector, charitable organisations and community groups.

2-3 contemporary visual art exhibitions, often new commissions and artist's first in the UK;

Multidisciplinary live events;

Creative learning projects (primarily focused on families, young people, and secondary schools).

All of these activities are artist-led and participantcentered and developed through meaningful and collaborative partnerships.

A bookshop stocking a wide range of contemporary Arab, global, and independent publishing projects

Guest accommodation and working studio

Podcast/broadcasting studio

Your time

Trustees need to attend 4 board meetings per year. Papers will be circulated before each meeting to be read in advance and allow you to prepare for the meeting. Board meetings are held in situ but can be attended online if necessary.

In addition to the board meetings, there will be an annual Board away day and may also be some additional training/board development sessions.

We want you to actively support and be interested in our work so there will also be events to attend e.g. exhibition openings, live programme, PR launches, fundraising events.

The role is unremunerated although expenses are offered for travel to Board meetings as required. This is standard as per charity law and we understand this will limit some people's ability to apply.

Board terms are 3 years and trustees can serve a maximum of 2 terms.
